## 4. Introduction:

We, Jeevak Health care India Enterprises, started in Sept 2017 with licensing, erection and other formalities we started our production in Sept 2018. With the principle of quality product at affordable cost we approached to the market and we got success to achieve rational figure of revenue.

But due to inadequate loan amount and delayed FDA license we come to the situation where the difference was raised from the market for shorter period. To fulfil the commitment, we drained out with the working capital.

At this point I looked upon for any working capital partner twice but somehow sleeping partners failed to raise the funds in full and we again got in to the same situation.

To come out the situation and to cope up with bank liabilities we have decided for liquidation of brand, plant and formulation at very affordable cost. Merely 50% of the new plant setup.

Basically it is *only plant in Maharashtra with very higher side of production capacity* of 3000 kg/day in cotton and bandages and 5000ltr/day in liquid based products.

## 5. Proposal:

As from above introduction you have realised that we are standing in position to liquidate our everything.

So, we propose that for liquidation of our assets, raw material along with our brand name, we ask a fair amount of 5cr. INR + Taxes. In return we will deliver you our machine, design of unit, raw material, product manufacturing procedures, operational guidelines. - 1. Availability of funds to purchase the unit, to transport and erect the unit, licensing and to purchase partial raw material (Raw material purchase we will discuss in details in meeting)
- 2. *Land:* of 30,000 or more sq. ft. of which 20,000 sq ft shed of which 6000sq. ft can be with fabrication work with at least 30ft height and rest 14000 can be ok with enclosed shed with height of 17-20ft. where changing room, laboratory, and other facilities as per FDA norms can be adjusted.

- 4. *Electricity supply:* 200 HP will be the power required for starting of whole plant in continuous motion power requirement will be reduced.
- 5. **Water requirement**: water is very essential part in case of bleaching of cotton as well as raw material of the product in liquid based production.
  - The hardness of water needs to be insured for below 10 for best product result. A batch of 500kg bleaching will take around 6000 to 8000 ltr. A tank of 5000ltr minimum need to be placed at height for the purpose of bleaching.
- 6. **Special requirements**: bleaching unit is totally foundation-based construction for machine. Rest liquid and post bleaching line doesn't required any special foundation. A crane facility of 5000kg capacity must be placed at the height of 30 ft for bleaching unit.
- 7. License & contract required: GST, Pollution control board, Food and Drugs (FDA) Medical devices & form 24, small industrial boiler authority licensing. Labour formalities like PF etc. fire safety, industrial safety. FDA Approved laboratory contract. Packing licence. Calibration AMC, Pest control AMC.


